Project value is then applied to the table below to determine the building permit fee.</p> <ul style="list-style-type: none"> <li>• Residential carports, covered porches, patios and decks use 50% of the value of a private garage (“utility, miscellaneous”) from the valuation table.</li> </ul> <p>New construction, Commercial: The valuation is the higher of:</p> <ol style="list-style-type: none"> <li>1. The valuation based on the ICC Building Valuation Data Table current as of April 1 of each year, using the occupancy and construction type as determined by the building official, multiplied by the square footage of the structure; or</li> <li>2.
