# Eugene Police Vehicle Compliance Program

*Making Eugene a safe place to drive*

## Easy Procedure

1. Correct or repair the violation.
2. Complete the Defendant portion of this form only.
3. Bring the citation, the completed form and the vehicle or documents showing the violation has been corrected to the Eugene Police Department **prior** to your court date. Compliance checks will be conducted at the Eugene Police Department Monday-Friday between 12:00pm and 6:00pm. You will have to wait for an available Police Officer or CSO to assist you.
4. If it is determined that the violation has been remedied, the remaining portion of this form will be signed off by a Police Officer or CSO. You will then need to take the completed form and pay a \$50 administrative fee to the Eugene Municipal Court.

As part of our goal to make Eugene a safe place to drive, Eugene Police developed a vehicle compliance program. Motorists who drive vehicles that do not comply with the law or fail to maintain updated information with DMV, may now correct those deficiencies and ensure your vehicle is safe for you to operate.

Some violations regarding equipment, vehicle registration, and driver licenses may be eligible for this program. If you can demonstrate, prior to your court date, that you have corrected the eligible violation, the citation you received may be dismissed.
