Eugene-Springfield HOME Consortium Governing Board	Vinis Semple	Acts as the intergovernmental decision-making body for federal HOME Investment Partnership Program (HOME) funds, received annually from the US Department of Housing and Urban Development to the Eugene-Springfield HOME Consortium. Provides leadership for the Consortium including review and approval of the annual HOME allocation, review of the Request for Proposals (RFP), and final decisions for use of HOME funds for development projects based on the decisions of the Evaluation Committee and respective City Councils. The Board is composed of two Mayors, one Springfield City Councilor, and one Eugene City Councilor. The City Councilors also participate on the RFP Evaluation Committee.	Location varies.
